#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

All dosages are for 10,000 gallons of water. Adjust accordingly.

#### BREAKOUT TREATMENT

To remove visible algae accumulations:

1. Brush areas affected with algae accumulations.
2. Add 4oz. (4 capfuls) of the "Yellow Stuff™" per 10,000 gallons. For severe accumulations add 8oz. per 10,000 gallons.
3. Add 1 lb. of dry chlorine or 1 gallon of liquid chlorine per 10,000 gallons to superchlorinate.

Swimming can be resumed a few hours after treatment.

#### MAINTENANCE TREATMENT

To prevent visible algae accumulations:

Separately add 4 oz. (4 capfuls) of "Yellow Stuff™" and 1 lb. of dry chlorine or 1 gallon of liquid chlorine per 10,000 gallons per week.

Swimming can be resumed a few hours after treatment.
